Call to order/Roll call of Commissioners:

The meeting of the Cherokee Nation Election Commission was called to order by Chairperson Shawna Calico at 5:07 p.m.

Once the office receives the written request to withdraw or change, the office should return the original Absentee Ballot Request by email, mail, in person or by fax. The office should make a copy of the original Absentee Ballot Request and attach it to the request received to withdraw or change the Absentee Ballot Request.

A motion was made by Rick Doherty and seconded by Carolyn Allen to approve the procedure suggested by Attorney and to include that any request to cancel, withdraw or change the Absentee Ballot Request must be in writing, preferably on the form prescribed by the Election Commission, with the information required on the initial request and to be delivered to the Election Commission.
