I. CALL TO ORDER:

Chairman Sparks called the meeting to order at 9:57 A.M.

II. ROLL CALL:

Three (3) commissioners were present and a quorum was established.

III. APPROVAL OF AGENDA:

Chairman Sparks, the first item on the agenda is the approval of the Agenda. Commissioner Hull motions to approve the agenda; seconded by Commissioner DeLozier. Motion carried.

IV. APPROVAL OF MINUTES:

Chairman Sparks, the next item is the approval of the Minutes as previously distributed.

Commissioner Hull motions to approve the Minutes; Seconded by Commissioner DeLozier. Motion carried.

The reports under item VI. A., B., C., and D. were received in Executive Session and no action was taken. Commissioner Hull motioned to exit Executive Session; Seconded by Commissioner DeLozier. Motion carried and the Commission exited Executive Session at 10:29 A.M.

VIII. NEW BUSINESS

Chairman Sparks, Now on item VIII. A. Permits and Licenses.

A. PERMITS & LICENSES – F. NORTHINGTON

Florence Northington presented the Permits & Licenses and recommended approval.

Commissioner Hull motioned to approve the twenty-nine (29) new electronic game themes, one (1) new main program, one (1) new game client, three (3) new gaming component, two (2) new gaming cabinets, and affirmation of six (6) Executive Director approved items; Seconded by Commissioner DeLozier. The motion carried.

2 WSS FOOD HALL MOMENTO CHIPS – AFFIRMATION

Chairman Sparks, Next is VIII. B. 2. The food hall momento chips affirmation. Present for Ms. Cochran is Kyle Sourjohn. The Chair entertained a motion to affirm the Executive Directors prior approval. Commissioner Hull made the motion to affirm said approval; Seconded by Commissioner DeLozier. The motion carried.

The Chair posed a request for more information from Mr. Sourjohn who presented a quick overview of the promotion. To commemorate the opening of the new West Siloam Springs (WSS) Food Hall, Marketing will be offering “promotional chips” in framed cases to VIP guests at the time of the event. Mr. Sourjohn noted this promotion has been previously approved and the chip itself cannot be used for gaming and has no cash value.

Mr. Sourjohn presented examples of the Food Hall Momento chips.

C. SICS MEMO – K. SOURJOHN

Chairman Sparks, moving on to VIII. C. SICS Memo.

Based upon CNGC review, CNGC Compliance recommended approval for one (1) new SICS and four (4) revised SICS as listed in the memo.

Commissioner DeLozier made the motion to approve the SICS Memo; Seconded by Commissioner Hull. Motion carried.

D. PROMOTIONS MEMO – K. SOURJOHN

Chairman Sparks, moving on to item D. Promotions Memo and the items contained therein.

Kyle Sourjohn presented the Promotions Memo for Ms. Cochran. CNGC recommended affirmation of the one (1) new Catoosa promotion, three (3) revised Catoosa promotions, and three (3) new corporate promotions as

previously approved by the Executive Director.

Motion to affirm the Executive Directors prior approval of items listed in the memo was made by Commissioner DeLozier; Seconded by Commissioner Hull. Motion carried.

E. IHP TRANSFER REQUEST MEMO - K. SOURJOHN

Chairman Sparks, now moving on to item VIII. E. IHP Transfer Request Memo.

Kyle Sourjohn presented and recommended approval for the transfer of retired in-house progressive (IHP) funds to promotional funds for the direct benefit of E-Games patrons.

Commissioner Hull made the motion to approve the transfer of IHP funds; Seconded by Commissioner DeLozier. Motion carried.

F. 2022 TICS TABLE GAMES REPORT – J. PURCELL

Chairman Sparks, now on to VIII. F. the Table Games Report. Chairman noted Ms. Imhoff absent. Executive Director Purcell for Ms. Imhoff stated the Table Games Report to the Commission was for informational purposes only, there was not a finding. The information was provided to and received by the Commission and no action was taken.

G. PRIZE CLAIM INVESTIGATION HEARING – K. SOURJOHN

Chairman Sparks, On to G. There is a prize claim investigation hearing. Executive session was requested and the Chair entertained a motion to enter Executive Session. Commissioner Hull made the motion to enter into Executive Session; Seconded by Commissioner DeLozier and the commission entered Executive Session at 10:49 A.M. to hear evidence and testimony on the Claimant's Petition. The Commission exited Executive Session at 11:30AM. The motion to exit Executive session was made by Commissioner DeLozier; Seconded by Commissioner Hull.

The investigation hearing of Item G, Tab 1, being completed, there was a Motion made to Deny the Individual Petition to Reverse the Denial of the Prize Claim which found that the Claimant did not have a bad beat by Commissioner DeLozier; Seconded by Commissioner Hull. The motion carried.


X. Adjournment:
