CHEROKEE NATION GAMING COMMISSION MEETING MINUTES

1 February 2019

Cherokee Hills Golf Course

CALL TO ORDER:

Chairman Sparks called the meeting to order at approximately 9:50 a.m.

ROLL CALL:

APPROVAL OF AGENDA:

Commissioner Purcell motioned to approve the agenda, seconded by Commissioner Goins. Motion carried.

APPROVAL OF MINUTES:

Commissioner Goins motioned to approve the 11 January 2019 meeting minutes. The motion was seconded by Commissioner Purcell. Motion carried.

INTRODUCTION OF GUESTS:

Introductions were made by attendees from the Cherokee Nation Gaming Commission (CNGC), Cherokee Nation Entertainment (CNE), Cherokee Nation Businesses (CNB), Cherokee Nation (CN), and guests.

Commissioner Purcell motioned to enter into executive session at 9:53 a.m. for the CNE reports; seconded by Commissioner Barrick. Motion carried.

Commissioner Purcell inquired on a recently reported complaint. Jamie reported that a complaint was received from the regional National Indian Gaming Commission office. A CNGC Compliance Officer spoke with the man on 30 January 2019; he had no specific information to provide other than being upset with the perceived lack of payouts at the casino. There is no issue at present.
